I am to invite your attention to the Government order in the reference third cited where in general standing order for monthly fuel ceiling limit for various Government vehicles have been ordered.

2. In this connection, representation have been received from the Tamil Nadu Revenue Officials Association requesting to increase the fuel ceiling for the vehicles of Tahsildars and other revenue officials who are implementing Corono Virus prevention activities works in the State.

3. Besides Revenue Department, the Corono Virus prevention and preparedness works are also being carried out by various other departments such as Health and Family Welfare Department, Rural Development and Panchayat Raj Department, Municipal Administration and Water Supplies Department, etc.,
4. Further in G.O.(Rt).No.147, Home Dept, dated 30.03.2020, Government have ordered for exemption of fuel ceiling for the Police Department vehicles drafted for the works relates to curb COVID 19 for the period from 24.03.2020 to 30.04.2020.
5. In the circumstances, Government hereby ordered for exemption of monthly fuel ceiling ordered for the vehicles of Revenue Administration and Disaster Management Department, Health and Family Welfare Department, Rural Development and Panchayat Raj Department and Municipal Administration and Water Supplies Department for the period from 24.03.2020 to 30.04.2020 as a special case.
6. It is also ordered for exemption of monthly fuel ceiling for the other department vehicles for the period from 24.03.2020 to 30.04.2020, subject to condition that such fuel consumption should not exceed the eligible annual ceiling of the vehicles.
7. The Heads of Department concerned are directed to ensure that utmost economy is observed in the use of fuel during the above said period.
8. The Pay and Accounts Officer / Treasury Officer concerned are requested to admit and honor the monthly fuel bills for the Government vehicles without insisting the monthly fuel ceiling limit for the said period.
